

ABSTRAK

KABUPATEN KEBUMEN, 2026, KEPUTUSAN BADAN MUSYAWARAH DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN NOMOR 100.1.4.2/8 TAHUN 2026 TENTANG JADWAL ACARA DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN BULAN JUNI 2026.

Keputusan ini ditetapkan berdasarkan tugas dan wewenang Badan Musyawarah DPRD Kabupaten Kebumen untuk menetapkan jadwal acara rapat DPRD. Penetapan jadwal dilakukan berdasarkan saran dan pendapat melalui Rapat Badan Musyawarah serta sesuai dengan ketentuan bahwa hasil rapat alat kelengkapan DPRD ditetapkan dalam keputusan pimpinan alat kelengkapan. Oleh karena itu, perlu ditetapkan jadwal acara DPRD Kabupaten Kebumen bulan Juni 2026 sebagai pedoman pelaksanaan kegiatan DPRD. Dasar pertimbangan tersebut berpedoman pada Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025 tentang Tata Tertib DPRD.

Materi pokok Keputusan ini menetapkan jadwal acara DPRD Kabupaten Kebumen bulan Juni 2026 sebagaimana tercantum dalam lampiran yang merupakan bagian tidak terpisahkan dari Keputusan. Jadwal tersebut mencakup berbagai kegiatan DPRD, antara lain rapat dan kegiatan Komisi, Badan Pembentukan Peraturan Daerah, Badan Anggaran, Badan Kehormatan, Badan Musyawarah, Pimpinan DPRD, Panitia Khusus pembahas Raperda, rapat paripurna, public hearing, kegiatan luar provinsi, kegiatan reses, serta kegiatan DPRD lainnya. Dalam jadwal tersebut juga ditetapkan agenda pembahasan beberapa Raperda, antara lain Raperda tentang Pengembangan Ekonomi Kreatif, Penataan dan Pengendalian Infrastruktur Pasif Telekomunikasi, Penyelenggaraan Kabupaten Layak Anak, serta Penyertaan Modal pada Badan Usaha Milik Daerah Kabupaten Kebumen.

Catatan: Keputusan ini ditetapkan di Kebumen pada tanggal 22 Mei 2026 dan mulai berlaku pada tanggal ditetapkan. Dasar hukum meliputi Undang-Undang Nomor 23 Tahun 2014 tentang Pemerintahan Daerah sebagaimana telah beberapa kali diubah terakhir dengan Undang-Undang Nomor 6 Tahun 2023, Peraturan Pemerintah Nomor 12 Tahun 2018 tentang Pedoman Penyusunan Tata Tertib Dewan Perwakilan Rakyat Daerah Provinsi, Kabupaten, dan Kota, serta Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025 tentang Tata Tertib DPRD. Keputusan ini memperhatikan Agenda DPRD Kabupaten Kebumen Tahun 2026 dan saran/pendapat Rapat Badan Musyawarah DPRD Kabupaten Kebumen tanggal 22 Mei 2026.

ABSTRACT

KEBUMEN REGENCY, 2026, DECISION OF THE CONSULTATIVE COMMITTEE OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY NUMBER 100.1.4.2/8 OF 2026 CONCERNING THE SCHEDULE OF ACTIVITIES OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY FOR JUNE 2026.

This Decision is stipulated based on the duties and authority of the Consultative Committee of the Regional House of Representatives of Kebumen Regency to establish the schedule of meetings and activities of the Regional House of Representatives. The schedule is established based on recommendations and opinions expressed through a meeting of the Consultative Committee and in accordance with the provision that the results of meetings of the organs of the Regional House of Representatives are stipulated in a decision of the leadership of the respective organ. Accordingly, it is necessary to establish the schedule of activities of the Regional House of Representatives of Kebumen Regency for June 2026 as a guideline for the implementation of its activities. The considerations are based on Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025 concerning the Rules of Procedure of the Regional House of Representatives.

The main substance of this Decision is the establishment of the schedule of activities of the Regional House of Representatives of Kebumen Regency for June 2026, as set forth in the appendix, which constitutes an integral part of this Decision. The schedule includes various activities of the Regional House of Representatives, including meetings and activities of Commissions, the Regional Regulation Formation Body, the Budget Committee, the Honorary Committee, the Consultative Committee, the leadership of the Regional House of Representatives, Special Committees discussing Draft Regional Regulations, plenary meetings, public hearings, activities outside the province, recess activities, and other activities of the Regional House of Representatives. The schedule also includes discussions of several Draft Regional Regulations, including those concerning Creative Economy Development, the Arrangement and Control of Passive Telecommunications Infrastructure, the Implementation of a Child-Friendly Regency, and Capital Participation in Regional-Owned Enterprises of Kebumen Regency.

Note: *This Decision was stipulated in Kebumen on 22 May 2026 and shall come into force on the date of stipulation. Its legal bases include Law Number 23 of 2014 concerning Regional Government, as last amended by Law Number 6 of 2023; Government Regulation Number 12 of 2018 concerning Guidelines for the Preparation of Rules of Procedure of Provincial, Regency, and Municipal Regional Houses of Representatives; and Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025 concerning the Rules of Procedure of the Regional House of Representatives. The Decision takes into consideration the 2026 Agenda of the Regional House of Representatives of Kebumen Regency and the recommendations and opinions of the meeting of the Consultative Committee held on 22 May 2026.*
