

ABSTRAK

KABUPATEN KEBUMEN, 2026, KEPUTUSAN BADAN MUSYAWARAH DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN NOMOR 100.1.4.2/8 TAHUN 2026 TENTANG JADWAL ACARA DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN BULAN JUNI 2026.

Keputusan ini disusun berdasarkan tugas dan wewenang Badan Musyawarah DPRD Kabupaten Kebumen untuk menetapkan jadwal acara rapat DPRD sebagaimana diatur dalam Pasal 64 ayat (1) huruf e Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025 tentang Tata Tertib DPRD [cite: 5]. Dalam rangka menetapkan jadwal acara rapat DPRD, Badan Musyawarah memberikan saran dan pendapat melalui Rapat Badan Musyawarah [cite: 5]. Selain itu, berdasarkan Pasal 93 ayat (2) Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025, hasil rapat alat kelengkapan DPRD ditetapkan dalam keputusan pimpinan alat kelengkapan [cite: 5]. Berdasarkan pertimbangan tersebut, perlu menetapkan Keputusan Badan Musyawarah DPRD Kabupaten Kebumen tentang Jadwal Acara DPRD Kabupaten Kebumen Bulan Juni 2026 [cite: 5].

Materi pokok Keputusan ini adalah penetapan jadwal acara Dewan Perwakilan Rakyat Daerah Kabupaten Kebumen bulan Juni 2026 sebagai pedoman pelaksanaan kegiatan dan rapat DPRD [cite: 5]. Jadwal acara meliputi libur nasional Hari Lahir Pancasila, rapat atau kegiatan Komisi, rapat Bapemperda, rapat Panitia Khusus pembahas Raperda (Pengembangan Ekonomi Kreatif, Penataan dan Pengendalian Infrastruktur Pasif Telekomunikasi, Penyelenggaraan Kabupaten Layak Anak, serta Penyertaan Modal pada BUMD), rapat Badan Kehormatan, rapat Badan Anggaran, rapat atau kegiatan Pimpinan DPRD, kegiatan Badan Kehormatan dan Komisi dalam/luar provinsi, rapat paripurna (persetujuan hibah BMD, penetapan pembahasan Raperda di luar Propemperda, pengambilan keputusan perubahan peraturan DPRD, pengucapan sumpah/janji anggota DPRD PAW, penyampaian Raperda PP-APBD TA 2025), public hearing, libur nasional Tahun Baru Islam 1448 H, kegiatan Panitia Khusus luar provinsi, kegiatan reses, serta rapat konsultasi pimpinan DPRD dan fraksi [cite: 5].

ABSTRACT

KEBUMEN REGENCY, 2026, DECISION OF THE CONSULTATIVE COMMITTEE OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY NUMBER 100.1.4.2/8 OF 2026 CONCERNING THE SCHEDULE OF ACTIVITIES OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY FOR JUNE 2026.

This Decision is formulated based on the duties and authority of the Consultative Committee of the Regional House of Representatives of Kebumen Regency to determine the schedule of meetings and activities of the Regional House of Representatives as provided for in Article 64 paragraph (1) letter e of Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025 concerning the Rules of Procedure of the Regional House of Representatives [cite: 5]. In determining the schedule of meetings, the Consultative Committee provides recommendations and opinions through its meetings [cite: 5]. Furthermore, pursuant to Article 93 paragraph (2) of Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025, the results of meetings of the organs of the Regional House of Representatives are stipulated in a decision of the leadership of the respective organ [cite: 5]. Based on these considerations, it is necessary to stipulate a Decision of the Consultative Committee concerning the Schedule of Activities of the Regional House of Representatives of Kebumen Regency for June 2026 [cite: 5].

The main substance of this Decision is the establishment of the schedule of activities of the Regional House of Representatives of Kebumen Regency for June 2026 as a guideline for the implementation of meetings and activities of the Regional House of Representatives [cite: 5]. The schedule includes the Pancasila Birth Anniversary national holiday, Commission meetings/activities, Regional Regulation Formation Body meetings, Special Committee meetings discussing draft regional regulations (Creative Economy Development, Passive Telecommunications Infrastructure Arrangement and Control, Child-Friendly Regency Implementation, and Capital Investment in Regional-Owned Enterprises), Honorary Body meetings, Budget Committee meetings, leadership meetings/activities, in-province/out-of-province activities for the Honorary Body and Commissions, plenary meetings (approval of regional-owned goods grants, stipulation of draft regulations outside the regional regulation formation program, decision-making on amendments to DPRD regulations, oath/pledge taking of interim replacement DPRD members, submission of the draft regional regulation on the accountability of the regional budget for the 2025 fiscal year), public hearings, the Islamic New Year 1448 AH national holiday, out-of-province activities for Special Committees, recess activities, and consultation meetings between the DPRD leadership and factions [cite: 5].
