

ABSTRAK

KABUPATEN KEBUMEN, 2026, KEPUTUSAN SEKRETARIS DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN NOMOR 1001.4.2/3144 TAHUN 2026 TENTANG PENDAMPING PANITIA KHUSUS DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN PEMBAHAS 4 (EMPAT) RANCANGAN PERATURAN DAERAH KABUPATEN KEBUMEN MASA PERSIDANGAN I TAHUN SIDANG 2026/2027.

Keputusan ini ditetapkan berdasarkan Keputusan Dewan Perwakilan Rakyat Daerah Nomor 100.2.1.4/28 Tahun 2026 tentang Pembentukan Panitia Khusus Pembahas 4 (empat) Rancangan Peraturan Daerah Kabupaten Kebumen Masa Persidangan I Tahun Sidang 2026/2027 serta ketentuan Pasal 84 ayat (4) Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025 tentang Tata Tertib DPRD yang menyatakan bahwa Panitia Khusus dalam melaksanakan tugasnya dibantu oleh Sekretariat DPRD. Berdasarkan pertimbangan tersebut, perlu menetapkan pendamping Panitia Khusus untuk mendukung pelaksanaan tugas pembahasan Rancangan Peraturan Daerah.

Materi pokok Keputusan ini menetapkan Tim Pendamping Panitia Khusus DPRD Kabupaten Kebumen Pembahas 4 (empat) Rancangan Peraturan Daerah Kabupaten Kebumen Masa Persidangan I Tahun Sidang 2026/2027 sebagaimana tercantum dalam lampiran. Pendamping Panitia Khusus bertugas melaksanakan kegiatan yang berkaitan dengan tugas Panitia Khusus, melakukan koordinasi dengan Panitia Khusus, Tim Ahli, Organisasi Perangkat Daerah terkait dan Pejabat Pelaksana Tugas Kegiatan dalam rangka pendampingan tugas Panitia Khusus, serta melaporkan hasil kegiatan kepada Sekretaris DPRD.

Pendampingan diberikan kepada 4 (empat) Panitia Khusus, yaitu Panitia Khusus I yang membahas Rancangan Peraturan Daerah tentang Pelindungan Pekerja Migran Indonesia; Panitia Khusus II yang membahas Rancangan Peraturan Daerah tentang Perubahan atas Peraturan Daerah Nomor 13 Tahun 2023 tentang Pengelolaan Sampah; Panitia Khusus III yang membahas Rancangan Peraturan Daerah tentang Perubahan atas Peraturan Daerah Nomor 4 Tahun 2021 tentang Sistem Perencanaan Pembangunan Daerah; dan Panitia Khusus IV yang membahas Rancangan Peraturan Daerah tentang Perubahan Ketiga atas Peraturan Daerah Nomor 7 Tahun 2016 tentang Pembentukan dan Susunan Perangkat Daerah. Biaya yang timbul akibat ditetapkannya Keputusan dibebankan pada Anggaran Pendapatan dan Belanja Daerah Kabupaten Kebumen Tahun Anggaran 2026.

Catatan: Keputusan ini ditetapkan di Kebumen pada tanggal 24 Agustus 2026 dan mulai berlaku pada tanggal ditetapkan. Dasar hukum meliputi Undang-Undang Nomor 13 Tahun 1950 tentang Pembentukan Daerah-daerah Kabupaten dalam lingkungan Propinsi Jawa Tengah, Peraturan Pemerintah Nomor 12 Tahun 2018 tentang Pedoman Penyusunan Tata Tertib Dewan Perwakilan Rakyat Daerah Provinsi, Kabupaten, dan Kota, Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025 tentang Tata Tertib DPRD, serta Keputusan DPRD Nomor 100.2.1.4/28 Tahun 2026 tentang Pembentukan Panitia Khusus Pembahas 4 (empat) Rancangan Peraturan Daerah Kabupaten Kebumen Masa Persidangan I Tahun Sidang 2026/2027.

ABSTRACT

KEBUMEN REGENCY, 2026, DECISION OF THE SECRETARY OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY NUMBER 1001.4.2/3144 OF 2026 CONCERNING ASSISTANCE TO THE SPECIAL COMMITTEES OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY DISCUSSING 4 (FOUR) DRAFT REGIONAL REGULATIONS OF KEBUMEN REGENCY FOR THE FIRST SESSION PERIOD OF THE 2026/2027 SESSION YEAR

This Decision is stipulated based on Decision of the Regional House of Representatives of Kebumen Regency Number 100.2.1.4/28 of 2026 concerning the Establishment of Special Committees to Discuss 4 (four) Draft Regional Regulations of Kebumen Regency for the First Session Period of the 2026/2027 Session Year, as well as Article 84 paragraph (4) of Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025 concerning the Rules of Procedure of the Regional House of Representatives, which provides that Special Committees are assisted by the Secretariat of the Regional House of Representatives in carrying out their duties. Based on these considerations, it is necessary to establish assistance teams for the Special Committees to support the implementation of their duties in discussing the Draft Regional Regulations.

The main substance of this Decision is the establishment of the Assistance Team for the Special Committees of the Regional House of Representatives of Kebumen Regency discussing 4 (four) Draft Regional Regulations of Kebumen Regency for the First Session Period of the 2026/2027 Session Year, as set forth in the appendix. The assistance team is tasked with carrying out activities related to the duties of the Special Committees, coordinating with the Special Committees, Expert Teams, relevant Regional Apparatus Organizations, and officials responsible for implementing activities in assisting the duties of the Special Committees, and reporting the results of activities to the Secretary of the Regional House of Representatives.

Assistance is provided to 4 (four) Special Committees. Special Committee I discusses the Draft Regional Regulation concerning the Protection of Indonesian Migrant Workers; Special Committee II discusses the Draft Regional Regulation concerning the Amendment to Regional Regulation Number 13 of 2023 concerning Waste Management; Special Committee III discusses the Draft Regional Regulation concerning the Amendment to Regional Regulation Number 4 of 2021 concerning the Regional Development Planning System; and Special Committee IV discusses the Draft Regional Regulation concerning the Third Amendment to Regional Regulation Number 7 of 2016 concerning the Establishment and Structure of Regional Apparatus. The costs arising from the implementation of this Decision are charged to the Regional Revenue and Expenditure Budget of Kebumen Regency for Fiscal Year 2026.

Note: *This Decision was stipulated in Kebumen on 24 August 2026 and shall come into force on the date of stipulation. Its legal bases include Law Number 13 of 1950 concerning the Establishment of Regencies within the Province of Central Java, Government Regulation Number 12 of 2018 concerning Guidelines for the Preparation of Rules of Procedure of Provincial, Regency, and Municipal Regional Houses of Representatives, Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025 concerning the Rules of Procedure of the Regional House of Representatives, and Decision of the Regional House of Representatives Number 100.2.1.4/28 of 2026 concerning the Establishment of Special Committees to Discuss 4 (four) Draft Regional Regulations of Kebumen Regency for the First Session Period of the 2026/2027 Session Year.*
