

ABSTRAK

KABUPATEN KEBUMEN, 2026, KEPUTUSAN BADAN MUSYAWARAH DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN NOMOR 100.1.4.2/11 TAHUN 2026 TENTANG JADWAL ACARA DEWAN PERWAKILAN RAKYAT DAERAH KABUPATEN KEBUMEN BULAN SEPTEMBER 2026.

Keputusan ini ditetapkan berdasarkan tugas dan wewenang Badan Musyawarah DPRD Kabupaten Kebumen untuk menetapkan jadwal acara rapat DPRD sebagaimana diatur dalam Pasal 64 ayat (1) huruf e Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025 tentang Tata Tertib DPRD. Penetapan jadwal dilakukan dengan memberikan saran dan pendapat melalui Rapat Badan Musyawarah. Selain itu, hasil rapat alat kelengkapan DPRD ditetapkan dalam keputusan pimpinan alat kelengkapan DPRD. Berdasarkan pertimbangan tersebut, perlu menetapkan Jadwal Acara DPRD Kabupaten Kebumen Bulan September 2026 sebagai pedoman pelaksanaan kegiatan DPRD.

Materi pokok Keputusan ini adalah menetapkan Jadwal Acara DPRD Kabupaten Kebumen Bulan September 2026 sebagaimana tercantum dalam lampiran yang merupakan bagian tidak terpisahkan dari Keputusan. Jadwal meliputi rapat paripurna, rapat Komisi, rapat Badan Musyawarah, Badan Anggaran, Badan Kehormatan, Bapemperda, rapat dan kegiatan Pimpinan DPRD, serta kegiatan Panitia Khusus. Agenda juga mencakup pembahasan Raperda tentang Penataan dan Pengendalian Infrastruktur Pasif Telekomunikasi, Pelindungan Pekerja Migran Indonesia, perubahan Perda tentang Pengelolaan Sampah, Sistem Perencanaan Pembangunan Daerah, Pembentukan dan Susunan Perangkat Daerah, serta beberapa Raperda terkait pemerintahan desa. Selain itu, jadwal memuat pembahasan APBD Tahun Anggaran 2027 dan P-APBD Tahun Anggaran 2026.

Catatan: Keputusan ditetapkan di Kebumen pada tanggal 24 Agustus 2026 dan mulai berlaku pada tanggal ditetapkan. Dasar hukum meliputi Undang-Undang Nomor 23 Tahun 2014 tentang Pemerintahan Daerah sebagaimana telah beberapa kali diubah, terakhir dengan Undang-Undang Nomor 1 Tahun 2026 tentang Penyesuaian Pidana; Peraturan Pemerintah Nomor 12 Tahun 2018 tentang Pedoman Penyusunan Tata Tertib DPRD Provinsi, Kabupaten, dan Kota; serta Peraturan DPRD Kabupaten Kebumen Nomor 1 Tahun 2025 tentang Tata Tertib DPRD. Keputusan ini memperhatikan Agenda DPRD Kabupaten Kebumen Tahun 2026 dan saran/pendapat Rapat Badan Musyawarah DPRD Kabupaten Kebumen tanggal 24 Agustus 2026. Keputusan dilengkapi 1 (satu) lampiran berupa Jadwal Acara DPRD Kabupaten Kebumen Bulan September 2026. Tidak terdapat keterangan mengenai pencabutan atau perubahan terhadap peraturan perundang-undangan lain.

ABSTRACT

KEBUMEN REGENCY, 2026, DECISION OF THE CONSULTATIVE COMMITTEE OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY NUMBER 100.1.4.2/11 OF 2026 CONCERNING THE SCHEDULE OF ACTIVITIES OF THE REGIONAL HOUSE OF REPRESENTATIVES OF KEBUMEN REGENCY FOR SEPTEMBER 2026.

This Decision is stipulated based on the duties and authority of the Consultative Committee of the Regional House of Representatives of Kebumen Regency to establish the schedule of meetings and activities of the Regional House of Representatives as provided for in Article 64 paragraph (1) letter e of Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025 concerning the Rules of Procedure of the Regional House of Representatives. The schedule is established through recommendations and opinions expressed in a meeting of the Consultative Committee. Furthermore, the results of meetings of the organs of the Regional House of Representatives are stipulated in decisions of the leadership of the respective organs. Based on these considerations, it is necessary to establish the Schedule of Activities of the Regional House of Representatives of Kebumen Regency for September 2026 as a guideline for the implementation of its activities.

The main substance of this Decision is the establishment of the Schedule of Activities of the Regional House of Representatives of Kebumen Regency for September 2026 as set forth in the appendix, which constitutes an integral part of the Decision. The schedule includes plenary meetings, meetings of Commissions, the Consultative Committee, the Budget Committee, the Honorary Committee, the Regional Regulation Formation Body, meetings and activities of the leadership of the Regional House of Representatives, and Special Committee activities. The agenda also includes discussions of the Draft Regional Regulation concerning the Arrangement and Control of Passive Telecommunications Infrastructure, the Protection of Indonesian Migrant Workers, amendments to regulations concerning Waste Management, the Regional Development Planning System, the Establishment and Structure of Regional Apparatus, as well as several Draft Regional Regulations concerning village administration. In addition, the schedule includes discussions of the 2027 Regional Budget and the Amendment to the 2026 Regional Budget.

Note: *This Decision was stipulated in Kebumen on 24 August 2026 and shall come into force on the date of stipulation. Its legal bases include Law Number 23 of 2014 concerning Regional Government, as amended several times, most recently by Law Number 1 of 2026 concerning Criminal Law Adjustments; Government Regulation Number 12 of 2018 concerning Guidelines for the Preparation of Rules of Procedure of Provincial, Regency, and Municipal Regional Houses of Representatives; and Regulation of the Regional House of Representatives of Kebumen Regency Number 1 of 2025 concerning the Rules of Procedure of the Regional House of Representatives. The Decision takes into consideration the 2026 Agenda of the Regional House of Representatives of Kebumen Regency and the recommendations and opinions of the meeting of the Consultative Committee held on 24 August 2026. The Decision has 1 (one) appendix containing the Schedule of Activities of the Regional House of Representatives of Kebumen Regency for September 2026. There is no provision concerning the repeal or amendment of other laws and regulations.*
