

RINGKASAN ISI

PROVINSI JAWA TENGAH, 2026, SURAT NOMOR B/100.3/612/2026 TENTANG HASIL FASILITASI RANCANGAN PERATURAN DAERAH KABUPATEN KEBUMEN TENTANG PENGEMBANGAN EKONOMI KREATIF..

Surat ini disusun sebagai tindak lanjut atas surat Bupati Kebumen Nomor 100.3/2320/2026 tanggal 21 Juli 2026 mengenai permohonan fasilitasi Rancangan Peraturan Daerah Kabupaten Kebumen tentang Pengembangan Ekonomi Kreatif. Fasilitasi dilakukan untuk menyelaraskan rancangan peraturan daerah dengan ketentuan peraturan perundang-undangan, memperjelas perumusan norma, menyempurnakan sistematika dan teknik penyusunan, serta memastikan konsistensi penggunaan istilah dalam pengaturan mengenai Pengembangan Ekonomi Kreatif.

Hasil fasilitasi memuat 16 pokok penyempurnaan, antara lain penghapusan salah satu dasar hukum dalam bagian Mengingat; sinkronisasi definisi Komite Ekonomi Kreatif Daerah; konsistensi penulisan istilah yang telah didefinisikan; dan peninjauan kembali ketentuan mengenai rencana pengembangan Ekonomi Kreatif dengan berpedoman pada Peraturan Presiden Nomor 37 Tahun 2026 tentang Rencana Induk Ekonomi Kreatif Tahun 2026–2045. Penyempurnaan juga mencakup pengaturan pembangunan infrastruktur Ekonomi Kreatif, pelaksanaan fasilitasi bimbingan teknis, dukungan promosi pemasaran, penyediaan sistem manajemen kolektif digital, pembentukan dan pengembangan Kawasan Ekonomi Kreatif, serta kolaborasi Pemerintah Daerah dalam memfasilitasi Pusat Ekonomi Kreatif. Selain itu, dilakukan perbaikan rumusan beberapa pasal, penghapusan ketentuan tertentu, penyempurnaan kewajiban Pelaku Ekonomi Kreatif, dan penyesuaian pengaturan sanksi. Rancangan Peraturan Daerah tersebut agar disempurnakan berdasarkan hasil fasilitasi untuk selanjutnya dapat ditetapkan menjadi Peraturan Daerah.

ABSTRACT

CENTRAL JAVA PROVINCE, 2026, LETTER NUMBER B/100.3/612/2026 CONCERNING THE FACILITATION RESULTS FOR THE DRAFT REGIONAL REGULATION OF KEBUMEN REGENCY CONCERNING CREATIVE ECONOMY DEVELOPMENT.

This Letter was prepared as a follow-up to the letter of the Regent of Kebumen Number 100.3/2320/2026 dated 21 July 2026 concerning a request for facilitation of the Draft Regional Regulation of Kebumen Regency concerning Creative Economy Development. The facilitation was conducted to align the Draft Regional Regulation with the provisions of laws and regulations, clarify the formulation of legal norms, improve its structure and legislative drafting technique, and ensure the consistent use of terms in the regulation of Creative Economy Development.

The facilitation results contain 16 principal recommendations, including the deletion of one of the legal bases in the Considering Applicable Laws section; the synchronization of the definition of the Regional Creative Economy Committee; the consistent capitalization of defined terms; and the reconsideration of provisions concerning the Creative Economy development plan by referring to Presidential Regulation Number 37 of 2026 concerning the Creative Economy Master Plan for 2026–2045. The recommendations also cover the development of Creative Economy infrastructure, the provision of technical guidance, promotional and marketing support, the provision of a digital collective management system, the establishment and development of Creative Economy Areas, and Local Government collaboration in facilitating Creative Economy Centers. In addition, several articles are to be reformulated, certain provisions deleted, the obligations of Creative Economy Actors refined, and the provisions concerning sanctions adjusted. The Draft Regional Regulation is to be revised in accordance with the facilitation results so that it may subsequently be enacted as a Regional Regulation.
